# **WHO WE ARE**

The Pasifika Lawyers Association of Queensland (PLAQ) is an independent, nonprofit, association that has been a home for Queensland based Pacific Island law students, lawyers and justice workers since its inception nearly 10 years ago.

In the period of 2021-22, PLAQ had the following financial members:

- 18 of these members are lawyers;
- 11 student members; and
- two are law degree holders who work across justice, health, education and beyond.

As we continue to build our profile, we hope our financial membership may also increase. However, in the loving spirit of our founders who valued access and inclusivity, our association continues to be open to all. As such, excluding the above financial members, we also have over 50 'casual' members who have registered with our association and subscribe to our 'Niusletters'.

#### Mentorship Sub-Committee Report

The Mentorship Sub-Committee aims to facilitate and build engagement, education, and professional networks for Pasifika legal professionals through the Association's signature Mentorship Program.

In the 2021-22 financial year we commenced a process of restarting the Association's program for an expected launch in 2023. We undertook research, consultation, and brainstorming into various mentorship models. As a result of this process, we formulated a mentorship agreement template that aims to enable a flexible and tailored agreement for future mentors and mentees in the program.

The Program will be aimed at linking Pasifika law students and new lawyers as mentees with experienced Pasifika and non-Pasifika mentors from a range of legal and legal-related fields.

Some of the key takeaways we identified, in developing this program include:

- the need to feature culture and cultural understanding within the program
- tailoring the program to be focused on agreed individual expectations and goals
- recognising the impact of COVID-19 and the need to be flexible with mentorship meetings
- aiming to make the program more accessible to persons from non-English speaking backgrounds and persons with disability

We expect with the rollout of the program next year, the Association will see an increase in program uptake, supported through targeted program marketing.



Our Events Sub-Committee strive to create and facilitate events that promote positive and inclusive spaces that celebrate our cultural heritage, build up diversity and legal knowledge for our members and the legal profession that we all serve in.

There are two notable events that our Events Sub-Committee are proud to highlight from this year. On 26 January 2022, Pasifika Lawyers Association hosted its New Year's Breakfast for 2022 at the Queensland Law Society House in the presence of our keynote speaker, the Honourable Chief Justice Catherine Holmes AC. Our members were blessed to share a meal, cultural dances and be inspired by Her Honour's speech on diversity within the profession, the significant changes that she has witnessed in her time as well as her hopes for the future of the legal profession. This event was also made possible by the Queensland Law Society's (QLS) support and hospitality. QLS President, Kara Thomson, in her closing remarks, emphasised that 'diversity is non-negotiable' in the legal profession. This vital standard was the perfect parting words to inspire our members and guests to continue to own and celebrate their diversity in serving our communities as legal professionals.









A historical event which signified another 'first' for PLAQ, was our first collaboration with the Pacific Legal Associations of New South Wales Inc (PLAN) and the Pacific Lawyers Association New Zealand. PLAQ was honoured to be a part of PLAN's premier event titled 'An Evening with the Honourable Chief Justice Satiu Simativa Perese'. The Honourable Chief Justice Perese of the Supreme Court of Samoa shared on 'Wellbeing and Insights as a Legal Practitioner of Pacific Heritage'. This was also the first time our PLAQ had been a part of such a monumental online gathering of Pacific islanders from all around the globe, which included university students, lawyers, barristers, solicitors, attorneys, registrars, legal/justice support people, Honourable Judges from New Zealand as well as our families and friends. Our sub-committee wishes to express a special thank you to the Pacific Legal Association NSW Inc and especially PLAN's President Mrs Brenda Milo for her vision in seeing the necessity, beauty and wisdom of bringing our three Pasifika Associations together to host such a significant and inspiring event. Also, thank you to Pacific Lawyers Association New Zealand for such a successful first collaboration; and that PLAQ looks forward to future collaborations with our fellow Pacific Legal Associations.



#### **Communications Sub-Committee Report**

The main goal of our Communications Sub-Committee is to highlight our Pasifika Lawyers association and how it engaged in its objectives to educate; to support; to network by sharing information and resources; and to facilitate conversations, events and forums in our community.

Our greatest achievement this financial year is our revamped website https://www.plaqld.org/ which is the landing page for all our social media and proudly declares our celebration of diversity. We are a group of Queensland lawyers and law students of Pasifika heritage who understand that our strength lies in community.

Social media has been our key tool to raise awareness about the association with our Instagram account at 487 followers; LinkedIn 477 followers; and Facebook with our greatest engagement with 1174 followers. Our posts generally are to celebrate achievements of our members, a fair number who have been newly admitted as legal practitioners; acknowledging key days that celebrate indigenous culture, promotion of Pasifika community events and knowledge sharing and the activities of our members networking in the community. We have also sought to ensure we provided regular updates of our activities and celebration of milestones with our Pasifika Lawyers Queensland 'Niusletter' of which three were issued in this financial year.

We have also seen our membership increase as we have made it easier for members and prospective members to sign up online through our Pasifika Lawyers Qld Facebook page as well as the website.
